### <u>ENGSCI 9501 – Business and Management: A Global Perspective</u> <u>Course Outline – 2016/17</u>

#### **Objectives:**

ENGSCI 9501L is an intense, comprehensive course covering fundamentals of business and management, from project financing and performance indicators to product life cycles and competitive advantage. The course will be held over nine meetings using a participatory model.

The aim of the course is to substantially prepare students for a transition from academia to private or public sector settings, familiarising them with management vocabulary and ideas.

The course will involve a non-trivial amount of work, and the payoff will be proportional to the effort.

#### **Topics:**

The following list details some of the specific aspects to be covered:

- 1. Introduction; business drivers; key success factors; Porter's five forces; PESTEL analysis; financial statements: reading, ratios, cost of capital, time value of money.
- 2. Forms of businesses; accounting vocabulary; depreciation and capital cost allowance; activity-based costing.
- 3. Working capital cycle; seasonality; credit, collateral, character and conditions; short- and long-term debt.
- 4. Public debt; project financing; budgeting; balanced scorecard and KPI; perverse incentives.
- 5. Maslow's hierarchy; market segmentation; unit contribution.
- 6. Risk reduction; product-service model; journey mapping; Blue Ocean framework.
- 7. Organisational structures; equity theory; unions and professional bodies.
- 8. Cognitive diversity; conflict resolution; management and leadership; Cost leadership and differentiation; trade chains; core competence; competitive advantage.
- 9. Non-market influences; concluding lecture.
