OUTSIDE OF CANADA APPLICATIONS

International students should apply for a **Study Permit** as soon as they receive an acceptance letter.

The study permit is a document issued by IRCC that allows [foreign nationals](#) to study at [designated learning institutions](#) (DLI) in Canada. Most foreign nationals need a study permit to study in Canada. Make sure you have all the documents you need before you apply. You should apply **before you travel to Canada**.

Your study permit is not a visa. It doesn't let you enter Canada. You may also need a [visitor visa or an electronic travel authorization \(eTA\)](#). If IRCC approves your study permit, they will issue one to you with your study permit.

RECENT CHANGES ON SP APPLICATIONS

- As of 8:30 am ET on **January 22, 2024**, new SP applications (except those who are exempt) are required to include a **provincial attestation letter (PAL)**. Without this PAL, SP applications will be returned with a full refund to the student. Each province or territory is expected to establish a process for issuing attestation letters by **March 31, 2024**.
- For **2024**, international students need to demonstrate a minimum of **\$20,635** (equal to 75% of LICO) + first year of tuition and travel costs for proof of financial support in their study permit applications. Moving forward, minimum financial requirement for new study permit applications will be increased and will be adjusted annually to reflect LICO accordingly.

STUDY PERMIT APPLICATION DOCUMENTS

Acceptance letter

- Issued by Western University
- **Conditional acceptance and prerequisite courses**
- If you've been conditionally accepted, this means you need to take prerequisite courses. For example, these might be English as a second language courses. You must complete these before you can start your main study program.
- If this is the case, IRCC will only issue your study permit for the length of those courses plus 1 year. Once you're accepted into your main program, **you'll need to apply for a new student permit to extend your stay as a student.**

Financial resources

- You must prove that you can support yourself, and the family members who come with you, while you are in Canada.
- **Required amount** is tuition fee plus \$20,635 minimum for living expenses for one person.
- **You can prove your funds with**
 - proof of a Canadian bank account in your name, if you've transferred money to Canada
 - Guaranteed Investment Certificate (GIC) from a participating Canadian financial institution
 - your bank statements for the past 4 months
 - a bank draft that can be converted to Canadian dollars
 - a letter from the person or school giving you money or
 - proof of funding paid from within Canada

Biometrics, Medical and other requirements

- **Biometrics**-Normally, you need to give biometrics **once every 10 years** if you apply for:
 - a visitor visa
 - a work or study permit (excluding US nationals)
 - permanent residence
 - refugee or asylum status
 - an extension of your stay in Canada, known as a visitor record (as of December 3, 2019)
 - a work or study permit extension (as of December 3, 2019)
- **Medical Exam** may be required in some circumstances.
- Check the [visa office instructions](#) for your country or region for local requirements.

TEMPORARY RESIDENT VISA (TRV)

Your study permit authorizes you to study and remain in Canada

If you are a citizen of a **visa-exempt** country, you must have a valid **electronic Travel Authorization (eTA)** and a passport to travel to and re-enter Canada. An eTA is valid for 5 years. You do not need a visa.



Most people need a valid temporary resident visa (TRV) in your passport in order to travel to and re-enter Canada



You can apply for a new TRV in your passport from within Canada AFTER you receive your new study permit

Your application to study in Canada has been approved. A permit authorizing your studies will be issued to you on your arrival to Canada following an examination by an officer of the Canada Border Services Agency, subject to your compliance with the requirements of the *Immigration and Refugee Protection Act* and its Regulations. The officer will ask to see this letter, your passport and may request to see your supporting documents, such as the letter of acceptance from your educational institution. Do not pack these or other valuable papers in your checked luggage. You can find out more about which documents you will need to bring with you by visiting www.cic.gc.ca/english/study/study-arriving.asp

As you gather your documents, please take note of the following:

- **This letter is not a passport or travel document.** You will not be permitted to board your flight without your passport, even if you have this letter with you.
- **This letter is not an authorization permitting you to enter or remain in Canada.** An officer of the Canada Border Services Agency will make that determination upon your arrival to Canada.
- **This letter is important** because it contains information that will be used by the Canada Border Services Agency to issue your study permit. Please do not misplace it.

You must seek entry to Canada to obtain your study permit by 2018/03 /21 (yyyy/mm/dd). Your passport must be valid beyond the period you intend to remain in Canada. If not, the validity of your study permit will not be issued beyond the expiry date of your passport, or, for United States citizens and permanent residents, the validity date of your identity document.

Note: As an international student in Canada, it is your responsibility to ensure that you continue to meet the conditions of your study permit, including the requirement to actively pursue studies. Your study permit will automatically become invalid 90 days after you complete your study program, regardless of the expiry date indicated on your study permit. STUDENT DIRECT STREAM

Depending on where you live, you may be able to get your study permit faster through the **Student Direct Stream (SDS)**.

IRCC will try to process most SDS applications within 20 calendar days. However, some applications may take longer.

To get faster processing, students must

- give their biometrics as soon as possible
- meet all the eligibility requirements

SDS ELIGIBILITY REQUIREMENTS

Countries

- To be eligible for faster processing through the Student Direct Stream, you must:
- be a legal resident living in 1 of the following countries:
- *Antigua and Barmuda, Brazil, China, Colombia, Costa Rica, India, Morocco, Pakistan, Peru, Philippines, Senegal, Saint Vincent and the Grenadines, Trinidad and Tobago, Vietnam*

Requirements

- have an acceptance letter from a post-secondary designated learning institution
- live outside of Canada when you apply
- have proof you have paid your tuition for your first year of study
- have a Guaranteed Investment Certificate (GIC) of CAN\$20,635

Requirements

- Language tests results within 2 years meeting minimum required score –CAEL, CELPIP, IELTS (A or G), PTE, TCF, TOEFL
- get a medical exam before you apply (if you need one)
- get a police certificate before you apply (if you need one)
- Any additional documents

REQUESTING LETTER FOR SDS

SDS for Newly Accepted Students can be requested under Official Western Letters for Visa purposes.

- You need to log in to Student Centre using your Western User ID and Password.

To place an order for this letter you must:

- Have accepted your offer of admission
- You must have paid your 1st year of tuition (use last year's amount if this year's fees are not yet available). It is recommended that you use [GlobalPay](#) to make your payment.

REQUESTING LETTER FOR SDS

Note: the fees for the 2024-2025 academic year are not yet available. The fees found at [Western tuition fees](#) are applicable for the 2023-2024 academic year.

IN CANADA APPLICATIONS

You can apply for Study Permit from within Canada if you are in Canada and

- you have a valid study or work permit
- your spouse, common-law partner or parent has a valid study or work permit
- you're a minor child in primary or secondary school
- you're an exchange student or visiting student
- you completed a short-term course or study program required to be accepted at a DLI
- you or your spouse, common-law partner or dependent child has a temporary resident permit (TRP) valid for 6 months or more
- you're being sponsored to immigrate and you already applied for permanent residence
- you or your spouse, common-law partner or dependent child are subject to an unenforceable removal order
- you're the spouse, common-law partner or dependent child of:
 - an athlete on a team based in Canada
 - a member of the media
 - a member of the clergy
 - military personnel on duty in Canada or
 - an accredited foreign representative

APPLY FOR AN EXTENSION OF YOUR STUDY PERMIT

Apply at least 30 days before your current study permit expires

Maintained Status
You are authorized to remain in Canada under “maintained status” and continue your activities as long as you apply to extend your stay before it expires



DOCUMENT CHECKLIST

- Application to Change Conditions, Extend My Stay or Remain in Canada as a Student [IMM 5709]
- Passport (biographic data and any pages with a visa/stamp)
- Letter for visa purposes (issued within the past 30 days) from Student Central and/or Letter of acceptance
- Transcripts and/or proof of completion of prerequisite studies (if applicable)
- Proof of Financial Support (one year tuition + living expenses, i.e., \$20,000 + proof of tuition payment)
 - Bank Portfolio
 - Letter of support from other source, e.g., bank statements from family members, scholarship proof
 - Letter for visa purposes or Statement of Account from Student Central showing tuition paid
- Digital photo
- Optional Documents: Client Information
- Application fees: \$150.00



CHANGING YOUR DLI

You must notify Immigration, Refugees, and Citizenship Canada (IRCC) if you change or transfer to a different Designated Learning Institution (DLI) in Canada

HOW TO CHANGE YOUR DLI

You'll need:

- an online account (www.cic.gc.ca)
- your study permit number
- your new school's DLI number
- your new Student ID
- your start date at your new school

STUDY PERMIT HOLDERS MUST COMPLY WITH SP CONDITIONS

Study at a Designated Learning Institution (DLI)

- You must hold a study permit if you are in a program of 6+ months
- Students may study without a study permit if the program is under 6 months in duration
- If you change your DLI, you must notify IRCC

Actively pursue your program of study

- Remain enrolled and make reasonable and timely progress towards completing your program
- You do not need to notify IRCC if you wish to change your program of study
- DLI's are required to report on students status twice a year

Comply with the conditions on your study permit

- Study permits may authorize on-campus employment if you are a full-time student
- Off-campus employment is only allowed for students enrolled in programs of at least 6 months and leading to a degree, diploma or certificate

One of the common conditions/remarks on your study permit may indicate:

- *“may accept employment”*
- *“may work”*
- *“are eligible to work”*

WORKING ON CAMPUS

- Hold a **valid Study Permit** with working conditions
- **Maintain full-time** status at the designated learning institution (DLI)
- Get a **Social Insurance Number (SIN)** from Service Canada
- There is no limit in number of hours to work on campus

WORKING OFF CAMPUS

- Hold a **valid Study Permit** with working conditions
- **Maintain full-time** status at the designated learning institution (DLI)
- Get a **Social Insurance Number (SIN)** from Service Canada
- You can work up to **20 hours** per week during the academic year and full-time during scheduled breaks.
- Undergraduate students at Western have scheduled break during the summer. Graduate students are enrolled in three academic terms and have no scheduled break.
- To work full time in the summer, you must be full-time student in a program before and after the scheduled break.

CO-OP WORK PERMIT

- ❑ Some students at Western may have work as a requirement of their degree
- ❑ If internship, co-op, practicum, placement, experiential learning is an “essential part of your program of study”

You will need to apply for co-op work permit (CWP)

- ❑ Western University will be indicated as your employer
- ❑ CWP cannot be used for working off campus in jobs that are not part of the academic position approved by your academic department

WORKING AFTER GRADUATION

Students don't need a job offer to apply for work permit

- The PGWP is not employer specific
- You can work anywhere in Canada
- The job does not need to be related to your degree

To be eligible to apply for PGWP, students need to:

- Have completed** all program requirements in program of study, approved for PGWP, that lasted at least eight months at a DLI
- CONTINUOUSLY** studied **FULL-TIME** in Canada with the exception of part-time only in the final academic session

PGWP ELIGIBILITY

- ❑ Received written confirmation from Western that you have met the requirements for completing your academic program
- ❑ Received official transcript. Unofficial transcript from DLI's website may be accepted
- ❑ You **MUST hold a valid study permit** when you apply for the work permit if you plan to start working under R186(w)

PERMANENT RESIDENCY

Students can book an appointment with a RCIC at the International and Exchange Student Centre to discuss on Express Entry and Permanent Residency pathways.

- Express Entry System (CEC, FSW)
- Ontario Immigrant Nominee Program – Masters Graduate Stream, PhD Graduate Stream or OINP International Students with Job Offer
